QUESTION: Shall the Board of Education of the Oran R-III School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Eight Hundred Fifty Thousand Dollars (\$1,850,000) for the purpose of providing funds for the betterment of school facilities including, without limitation: to replace roofs at the High School, Library, and Central Office; to repave and expand the parking lot; to renovate the Science Lab and Family and Consumer Services (FACS) Room; to complete an addition to the High School Lobby; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue bonds for the payment thereof?
If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.8500 per one hundred dollars of assessed valuation of real and personal property.

If this proposition is approved, the adjusted debt service levy of the District is estimated to increase \$0.42 per one hundred dollars assessed valuation from \$0.21 to \$0.63 per one hundred dollars assessed valuation of real and personal property.
